- Offer a variety of play components promoting physical activity, creativity, and social-emotional growth.
- Ensure compatibility with the surrounding school campus and site conditions.

3. Scope of Work

The selected contractor will be responsible for:

- Conducting a site evaluation and working with school representatives to gather input.
- Designing a playground that meets the district's educational and recreational objectives:
 - Singular play structure with 2 platform levels, max height 8' (no wooden structures)
 - 2 slides
 - 6+ swings
 - 4 independent climber/play objects away from main play structure
 - Procuring and delivering all necessary equipment and materials.
- Installing playground components, safety surfacing, and additional site furnishings (e.g., benches, shade structures).
- Coordinating permits, inspections, and final safety certification.
- Providing user manuals, warranties, and maintenance guidelines.

4. Proposal Requirements

Each proposal must include:

- Company profile and relevant experience.
- A minimum of three references from similar projects within the last five years.
- Preliminary playground designs, including equipment specifications and layout visuals.
- Detailed project timeline and proposed milestones.
- Complete cost breakdown (design, equipment, shipping, installation, surfacing, etc.).
- Color choices for each item, with color charts or chips.
- Warranty information and maintenance recommendations.

- Proof of insurance and required licenses.
- Certification of compliance with all applicable safety and accessibility standards.

5. Evaluation Criteria

Proposals will be evaluated based on the following:

- Quality, innovation, and inclusivity of the design
- Total project cost and value
- Compliance with ADA, CPSC, and NPPS
- Experience and qualifications of the vendor
- References and past performance
- Proposed timeline and project management approach
